I am looking for dedicated, dependable girls and young women talent 5 through 25 who are passionate about their craft and are interested in developing a *professional portfolio*. Those interested should be cheerful, upbeat and conscientious about the quality of their communicators. Photo sessions are light hearted, high spirited, and laid back. The location for photo sessions will be at my studio in my home in Garland and immediately outside the studio. After we've exchanged all of our information, you are encouraged to come by my place, meet me, check the place out, and discuss your shooting ideas on a date before your photo session.

It should give you a good comfort level with what the setup and my shooting style are like. I'm open to shooting other styles (within my capabilities) too, so you are not constrained by what you see on the site.

You will be rewarded with:

- **Proofs** of the entire photo session on CD on completion of the shoot (not for publication of any kind, posting on Facebook or the like, emailing or other distribution including to agencies and casting personnel). I'll need you to sign a Release From Liability form in order for me to give you the CD. The only purpose of the proofs is to allow **you** to choose photos for me to consider to finish (retouch).
- After a set of photos has been retouched I will mail to you a CD containing all retouched images at full print-ready resolution including a label with my signature authorizing reproduction (including publication on Web sites of your choosing), a separate form, Assignment of Reproduction/Publication Rights, signed by me authorizing reproduction, and a contact sheet with thumbnails of all processed images on the CD.
- Instant fame as your images appear on my Web site at [www.techno-imaging.com](http://www.techno-imaging.com) (your approval sought) which serves as an on-line portfolio for both of us. I can link from your entry on my site to your pages on profile hosting sites to enhance your exposure.

NOTE: Both you and I can decide which photos do and do not make it to my Web site, however you have the final veto. We can take some pictures that I can retouch for you for your book that don't go on the Web. I don't give out unprocessed camera images to anybody. I will process only those photos I consider flattering to the model and which represent me as a professional photographer. I apply my copyright signature to each finished photo. Reproduction/Publishing rights assigned to model are not transferable. That means the model cannot give permission to a magazine, for example, to publish her photos for profit.
